

University of Washington Endowment's investment portfolio is valued at \$3.3 billion, with investments in developing and emerging market equities, fixed income, real assets, opportunistic and absolute return strategies. For the 1, 5 and 10 years ended June 30, 2015, the total fund returned 11.9%, 10% and 7.5%, respectively. As of June 30, 2015, the private equity portfolio was valued at over \$363 million, representing 11% of the total portfolio. The private equity portfolio is currently underweight

compared to the target allocation of 15%. Investments in private equity include buyout, co-investments, debt, fund of funds, mezzanine, private growth equity, distressed debt, secondaries more »
